TERMS OF SALE

* A non-refundable deposit of \$100 is required to hold the kitten. When the sale of kitten is consummated, the deposit shall be applied toward the purchase price.

*Purchaser agrees to spay/neuter feline between the ages of 4-7 months.

* Guarantees that the feline WILL NOT be used for studs or breeding. If it is found that said feline is being used for breeding, Elkridge Bengals has the right to reclaim the above named feline or receive an additional \$1000 for breeding rights. It will be the decision of the seller whether to reclaim the feline or collect the appropriate fees. Any legal fees incurred in reclaiming the animal will be paid by the purchaser.

*Seller agrees to provide registration papers for the feline upon presentation of a veterinarian's certification of spay/neuter. Proof may be sent via email, fax, or regular mail.

*Rabies vaccination will be done by 16 weeks of age.

*There will be no monetary refunds of deposits, purchase price, shipping costs, veterinary expenses or any other costs. Purchaser assumes all responsibility for costs.

*This feline is guaranteed to be in good health at the time of purchase. Purchaser has 3 business days to have an exam performed by a veterinarian, and to report any questionable findings. Questionable findings must be submitted in writing to the seller.

*If the feline is found to be medically deficient with an untreatable or life threatening problem it will be replaced with another feline of equal value. If no replacement is available at the time the seller will have a reasonable amount of time to furnish a satisfactory replacement.

*The feline may not be returned for replacement after the guarantee period has expired or if it has been exposed to another cat or allowed outside.

*If feline dies within the guarantee period, despite medical treatment, a replacement will only be given upon written certification by a veterinarian on the cause of death.

*This feline is guaranteed against congenital defects for 6 months. Should the feline die within that time as a result of a congenital defect, the feline will be replaced only if an appropriate necropsy is performed by a licensed vet. The veterinarian's certificate must be provided as proof of cause of death. If all conditions are met seller will replace the feline with one of equal quality/value.

By signing below the purchaser is in full agreement of all the above conditions. Any legal fees occurred in upholding this contract will be the responsibility of the purchaser.
